The University is advised to comply with the Review Panel's decisions, while considering the definitions of the status of program as mentioned below:

**Halted:** The University should halt all the activities of the program, including conduction of classes, examination, thesis defense, award of degrees etc. until HEC/Program review team permits.

Further Intake Stopped: The University should not admit any scholar in the program until HEC/Program review team permits. The program for enrolled student would run provided that other identified deficiencies are rectified.

**OK**: The program is meeting the minimum requirements as per HEC criteria and it may be continued accordingly.

Further Intake Stopped: The university should stop further intake in MD (Pulmonology), MD (Nephrology), and MD (Emergency Medicine) programs until they get accreditation from PM&DC.

The programs for enrolled student would run provided that other identified deficiencies are rectified. Rests of the programs are *OK*.

#### FINDINGS:

- Credit hours of MD/MS/MDS Programs are not well defined and have variation in different programs.
- 2. MD (Pulmonology), MD (Nephrology), and MD (Emergency Medicine) programs are not accredited by PM&DC.
- 3. There is only one faculty member available in MS (Thoracic Surgery), which is not fulfilling the faculty requirement minimum criteria of the Higher Education Commission. As per HEC criteria, there is a minimum of 02 faculty members required for MD/MS/MDS programs.
- 4. The maximum duration of MD/MS/MDS programs must be defined and approved by the statutory bodies.
- 5. HEC Digital Library is underutilized, yet it offers a wealth of resources that can significantly enhance research and learning opportunities. By promoting its diverse collections and user-friendly access, we can encourage more students and faculty to take full advantage of this invaluable tool.
- 6. Student's life cycle at KEMU, from admissions and enrollment to graduation and alumni engagement, is not implemented completely. This comprehensive system will streamline processes, enhance communication, and provide valuable data insights to improve the overall student experience and institutional efficiency.
- 7. In compliance with HEC Graduate Policy, several postgraduate trainees have extended their training period.
- 8. Approval trail of Program/Curricula from BOS, BOF, Academic Council, and Syndicate is not available to all Program Directors in their Program Files.

### RECOMMENDATIONS:

- The Medical Education Department and Curriculum Committee is required to create and circulate a common template of credit hours for all MD/MS/MDS programs.
- 2. MD (Pulmonology), MD (Nephrology), and MD (Emergency Medicine) programs should be accredited by PM&DC.
- At least one more faculty member should be immediately recruited/transferred from SHC&ME or university cadre in the Thoracic Surgery department to fulfill HEC minimum criteria.
- 4. Maximum duration of MD/MS/MDS needs to be approved and implemented, i.e., for a 05-year program, a maximum of 08 years should be given, and for a 04-year program, a maximum of 07 should be given, in alignment with graduate policy, 2023.
- 5. The chairman of the library committee and the director of IT make sure that library credentials are shared with research students/supervisors.
- Campus Management System (computerization) should be implemented to cover the complete student life cycle at KEMU.

- 7. No extension should be given to any student beyond the HEC Graduate Policy. The maximum time period to complete an MD/MS/MDS or equivalent program should be 08 years.
- 8. Approval trails of programs/curricula from BOS, BOF, Academic Council, and Syndicate must be available to all program directors in their program files.
