NOTIFICATION

As approved by the Competent Authority as well as in pursuance of the approved University policy, the following instructions shall be observed with immediate effect regarding internal assessment, enrollment, and attendance of MBBS students:

- Internal Assessment marks shall be submitted once annually before the Annual Professional Examination. The same Internal Assessment shall be considered for both the Annual and Supplementary Professional Examinations.
- A student who fails in both the Annual and Supplementary Professional Examination in a particular subject shall be declared detained in that subject only and shall be enrolled with the next academic session for the concerned subject.
- The Internal Assessment of such detained students shall be calculated as follows:
 - 50% weightage shall be carried forward from the last attended academic session.
 - 50% weightage shall be based on the student's attendance and performance from the date of re-enrollment until the end of the current session.
- No student shall be permitted to appear in the Professional Examination unless he/she is formally enrolled in the relevant classes.
- Detained students shall be required to attend classes of the detained subject(s) only.
- Foreign graduates who are unable to attend physical classes may, with the approval of the University, be offered an online module. Attendance and assessment through the approved online module shall be considered for Internal Assessment. Such students must submit a written request to the University through the prescribed official email channel.
- All concerned Deans, Principals, Heads of Departments, and students are directed to ensure strict compliance with this notification.
